Chair Hood called the meeting to order at 4:00 pm

Brewster Water System: Superintendent of Brewster Water System; Paul Anderson.

Concern is the distribution of the 4-inch lines, at Coles Neck.

Small number of clients on the system, there will be issues on the revenue side of things.

Not a great deal of service connections which will complicate things for the town.

Complicated revenue stream. Fire protection - Lower insurance rates for the commercial community. Lower insurance rates for community.

Municipal Water supply – To provide clean drinking water. Easier to maintain a Municipal Water Supply rather than private wells.

System laid out very well and could be expanded on. The only issue is the 4-inch water main.

Recommendation:

- Cross Connection: Do a Survey to go into Commercial Properties to conduct a survey.
 i.e., Marina
- Billing information Difficult getting information from Pennichuck.
 - A Rate study is recommended to be completed by a third party.
- License operation To hire a person to do in house billing since the system is small enough to handle internally.
- Expansion is possible look for that through the town. Look at existing infrastructure to increase homeowners. Look at revenue which could be brought in. Then look at future infrastructure.

Boy Scott Camp Well: Update

Depth Censor: 71 ft of water in each well. Wells are 150ft deep. The SCADA system had scaling issues and has been corrected. One of the cables has a cut in it. And the censors are at different levels within the two wells. Move forward with that quote with Butch - Coordinate with White Water.

DEP Sanitary Survey

Corrective option plan:

- 1. Floor Drains for both pump stations need to be in accordance with underground injection control regulations and need to get submittal transmittal forms and permits to DEP.
- 2. Process instrumentation waste from continuous analyzers and/or sampling sinks must discharge to a UIC Class V well. The well must be registered using registration form.
- 3. Develop a written alarm testing procedures and record in a logbook all alarms testing.

PFAS Testing Status

- John Apria Samples to be taken. The Testing kits have been delivered on September 4, 2021

Sampling first quarter of each quarter starting on October 1st. Every three months for next year.

New regulation for October 1st. Different action items due to results. If no PFAS found during the sampling period, the frequency of the testing will be reduced. However, a minimum of four tests needs to be completed. Starting on October 1st it is a new regulation and not voluntary.
