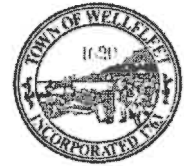

ANNOUNCEMENT OF AVAILABILITY OF SHELLFISH LICENSE GRANT #01-05

The Town of Wellfleet Shellfish Department and Board of Selectmen announce the availability of shellfish grant license # 01-05, a three-acre parcel located off Indian Neck. At the time of posting, access to this grant is limited to foot and boat only.

Applications may be picked up at the Principal Clerk's office on the second floor of Town Hall or downloaded from the Shellfish Dept. webpage. The application period will be open for 30 days. Applications must be turned in to the Principal Clerk's office by noon on May 24, 2018. No exceptions will be made.

Applicants must satisfy all criteria listed in the Town of Wellfleet Shellfishing Policy and Regulations, Section 7. No exceptions will be made.

If more than one qualified person whose name does not appear on another license applies to hold the license, the Board of Selectmen will hold a public lottery within 14 days to impartially determine who shall be awarded the grant.

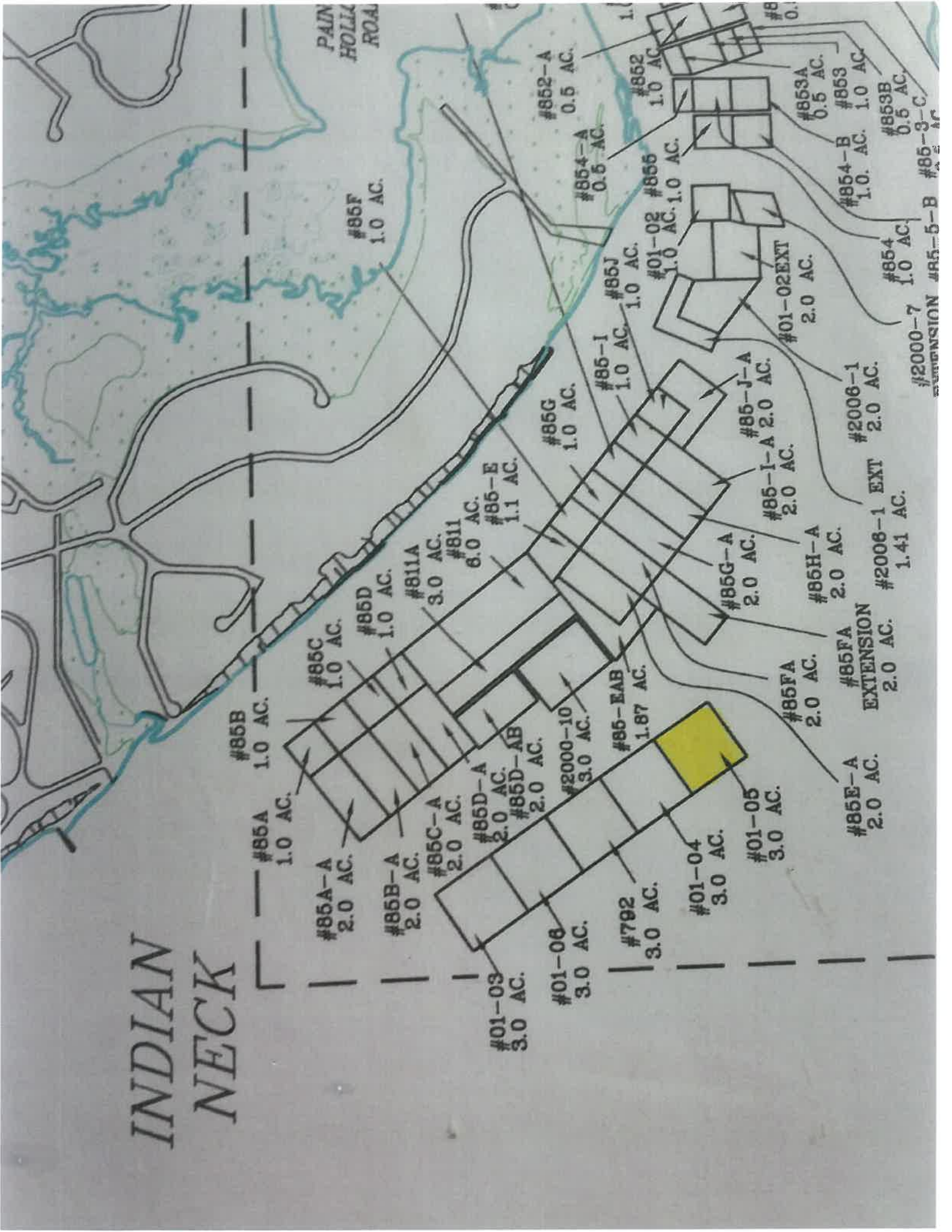
