EMERGENCY DECLARATION

WHEREAS, a sudden, generally unexpected occurrence of circumstances demanding public action has arisen within the TOWN OF WELLFLEET; and

WHEREAS, The BOARD OF SELECTMEN of the TOWN OF WELLFLEET, Massachusetts, upon advice form the Wellfleet Emergency Management Director Chief Ronald Fisette, or his designees, have determined that the incident poses a present, reasonable and imminent danger to public health, safety, or general welfare of the people of TOWN OF WELLFLEET or their property so that it has become necessary for the Director to utilize and coordinate the services, equipment, supplies, and facilities of existing departments, offices, and agencies or the community for the purposes of emergency management and emergency functions; and

WHEREAS, the Governor of the Commonwealth of Massachusetts has declared that the immediate public action is needed to prevent, minimize, or mitigate damage to public health, safety, or general welfare of the people of TOWN OF WELLFLEET or the property which may otherwise result from the above described incident and that taking the time required to comply with the various state and local procurement laws would endanger the health or safety of the people or their property; and procurement laws would endanger the health and safety of the people and their property; and

WHEREAS, the Governor of the Commonwealth of Massachusetts has recommended that a State of Emergency be declared in the TOWN OF WELLFLEET, and

WHEREAS, the people of the TOWN OF WELLFLEET should be able to depend upon guidance from their Emergency Management Director and the Board of Selectmen,

NOW THEREFORE, WE, THE BOARD OF SELECTMEN of the TOWN OF WELLFLEET, Massachusetts, hereby declare that as of 12 PM on SATURDAY, FEBRUARY 14, 2015 a State of Emergency exists in the TOWN OF WELLFLEET. This Declaration of Emergency shall remain in effect until 12:00 PM on TUESDAY, FEBRUARY 17, 2015.
