We will be reviewing the Capital Investment Plan for FY2024.

Rich Waldo: Announcements: The Town Accountant will be leaving on December 9.

Nauset Reginal School project – The general contract bid did not come in lower. High School Project - the amount came in at \$38.1M over the cost estimate. It is a 35% increase. Original cost was \$131 M and the MSBA was going to approx. \$30M.

## Review of the updated Capital Improvement Plan -

- A. \$250M Munis Software Conversion. This is for FY2025.
- B. Each year there will be annual cost for the software.
- C. COA Feasibility Study for Building Addition. It projects out to \$5M.
- D. Maintenance on Dredge (Channel) \$50K and \$3.2M in FY2029
- E. Police Fleet replacement \$130K
- F. Wastewater looking at 30.5M in FY2026
- G. Briar Lane Culvert DPW 75K FY 2024 and \$350K in FY 2025.
- H. Water Department: \$275K to replace the old meters no longer supported
  - a. 25K Software and Reader
  - b. 35K for a new generator
- I. Maurice's Campground:
  - a. Watermain Extension \$500K FY2024
  - b. Housing Development Planning & Development \$50K FY2024and \$5.3M over the next 6 years.
  - c. Wastewater System \$150K FY2024 and another 4M over the next 6 years
  - d. Capital Building Repairs \$240K
