
Cape Light Compact Demand Response Demonstration Offering - Ice Bear

Wellfleet Board of Selectmen -Tuesday, May 31, 2016

- The Green Communities Act requires the Cape Light Compact (Compact) to develop energy
 efficiency plans that provide for the acquisition of all available energy efficiency and demand
 reduction resources that are cost effective or less expensive than supply.
- 2. The Compact is required to submit its 2016-2018 Energy Efficiency Plan (EEP) to the Massachusetts Department of Public Utilities (DPU) for review and approval.
- 3. The DPU approved the Compact's 2016-2018 EEP on January 28, 2016.
 - a. Compact's EEP proposes a demand response offering for commercial and residential customers.
 - b. The goal of the Compact's demand response offering is to reduce participating commercial and residential electric customers' kilowatt hour usage in the summer during specific hours of the day.
 - c. Compact's demand response offering focuses primarily on air conditioning load.

4. ICE Bear Technology

- a. Thermal storage system that works in concert with AC units.
- b. Reduces demand by making ice during evening off-peak hours, when other building equipment is less likely to be running. During the daytime on-peak hours, when lighting, electronics, etc. are running in the building, the ice is used to cool the building in place of the high-demand AC unit compressor.



Next steps

- a. Meet with to vendor to:
 - Size units for each site verify units and installation are acceptable to Town and Compact
 - ii. Estimate demand reduction per site
 - Calculate estimated cost savings for Town from reduction in monthly demand charges at each site
 - iv. Develop design plans for each building
 - v. Develop installation schedule
- b. Review the installation and maintenance proposal prepared by vendor. Compact and Town determine whether or not to move forward.
- c. If Compact and Town agree to proceed, sign Participation Agreement for the Demand Response Offering with Cape Light Compact.
