1. The table below shows a summary of all submitted bids received - no arithmetic errors were found in the lowest bids.

Total Base Bid Price	\$2,591,800.00

2. The apparent low and only bidder is Cashman Dredging & Marine Contracting Company, LLC (Cashman); as depicted in the table above.
3. The bid provided by Cashman includes the required certifications, bid bond, and certificate of insurance.
4. The bid has multiple payment items which are within 3 percent of the engineers estimate and within allowable contract percentages.


