RE: Wellfleet Harbor and Mayo Creek Sediment Analysis: Two New Test Runs

Dear Mr. Riehl:

Woods Hole Group is pleased to provide the following cost proposal for a project to analyze the transport and fate of fine sediments (popularly termed black custard) in Wellfleet Harbor and Mayo Creek. The proposed project is a follow-on to a previous project entitled, "Wellfleet Harbor Mayo Creek Sediment Analysis," for which the work has been completed and the final report submitted. The scope of work for the follow-on project proposed here consists of the following Tasks:

Task 1: Calculations for Two Additional Cases

Woods Hole Group will use the information and methodologies developed during the preceding project to evaluate two additional cases for reducing need for the Wellfleet North Harbor conventional dredging following the restoration of Mayo Creek:

- 1. A North Harbor depth three feet below mean low water.
- 2. A North Harbor depth that is three feet below mean low water at the west end of the North Harbor and declining to five feet below mean low water at the east end, exiting into the main Harbor.

The idea behind both cases is that the higher flow velocities out of the Mayo Creek Salt Marsh might lead to a reduction of the rate of tidal sediment build-up in the North Channel.

Task 2: Reporting and Project Management

Woods Hole Group will communicate progress via brief emails and (if useful) follow-up phone conversations. After completion of the analysis, Woods Hole Group will provide a report that summarizes the approach, formulation, solution, and results. The report will be an addendum to the final report that was submitted for the previous project.
