RE: Commercial shellfishing permit hardship exemption requests:

Mary Mallory and Kathleen Murphy

Dear Selectboard members:

Mary Mallory is coming to you to request a hardship exemption because as a current grant holder, she missed applying for her commercial shellfishing permit by the February 28, 2023, deadline. I received her application and check on April 21, 2023, but by then, Town Counsel had recommended that grant holders out of compliance submit a hardship exemption request for missing the February 28, 2023, deadline. Therefore, I did not issue her a commercial shellfishing permit.

There is a public hearing tonight on a proposed grant extension for grant # 99-1, for which she holds a license. In order for you to approve her extension request, she will need to obtain a commercial shellfishing permit. She also needs the permit to be in current compliance with our regulations. She does have a state commercial shellfishing permit.

Therefore, she is coming to you for a hardship exemption tonight, and I support you allowing me to issue her a permit per our new regulations requiring all grant holders to obtain a commercial shellfishing permit. Her letter of explanation is attached.

Here are the specifications outlined in our Wellfleet Shellfishing Policy and Regulations:

REGULATION 6.1.4. Hardship Exemption

The Board of Selectmen may at its discretion grant permits after January 31st if the applicant demonstrates **all three** of the following conditions:

- 1) that unusual circumstances existed which would reasonably excuse a failure to file an application prior to February 1st, and
- that a substantial hardship would be caused by the refusal of a permit, and
- 3) that the granting of the late permit would not affect the opportunity of applicants, who have applied in a timely manner, to harvest a reasonable quantity of shellfish.

In addition, **Kathleen Murphy** is also requesting a commercial shellfishing permit hardship exemption. There is a public hearing tonight to add her name to grant #s 855, 855B and 855C. In order to be added to the grants, she will need to obtain a commercial shellfishing

permit. Following is the letter she submitted. Here are the points related to the above regulation.

- 1) Kathleen had no way of knowing that the Selectboard would request that she and her partner withdraw their previous grant transfer request due to the town not being able to issue a commercial shellfishing permit to a business entity.
- 2) She states in her letter that if something would happen to her partner, she would not be able to access her shellfish and gear because she is not named to the grant. (This is true because both Mass. General Law and Town Regulations provide only for immediate family members and not life or business partners.)
- 3) We see no adverse effect on other shellfishermen.

The Shellfish Department does not believe that the Selectboard intended to exclude shellfish grant transfer requests when it voted in the new regulation requiring all grant holders to purchase commercial shellfishing permits. In fact, discussion was had at the meeting specifically addressing the situation should new people request to be added to grants during the year.

As part of that discussion, I offered that the Selectboard could simply make a motion to direct me to issue the new applicant a commercial shellfishing permit. Town Counsel preferred that we conduct this via the hardship exemption regulation, and I let Kathleen know this. I strongly support you allowing me to issue her a permit, so that her name can be added to the shellfish grant license #s 855, 855A and 855B. She does have a state commercial shellfishing permit.

The public hearing for the commercial permit purchase requirement of grant holders opens around 2:06:15. The question and discussion beginning around 2:11:08 with my response at 2:15:24. The final motion for a vote begins around 2:20:45.

In addition, Johnny and Chris and I discussed these situations in more detail, and the Shellfish Department believes that in this first year of transition to a new regulatory requirement, both of these requests should be honored and commercial shellfishing permits be allowed to be issued, so as not to interfere with the overall regulation compliance both of these people demonstrate, simply because the Town created a new revenue stream.

Dear Esteemed Members of the Legislature:

We write to you today with a sense of urgency to consider moving along in the quickest way possible, Bill Number S261 and H603, An Act Relative to Universal School Meals.

During the pandemic, the Federal Government implemented a universal free meal plan through the end of the School Year in June 2022. Last year, Governor Baker extended that initiative on the state level to the end of this present school year in June 2023. As of now, there is no federal or state initiative passed to extend the plan, and the Universal Free School Meals initiative ended in June of this year.

We all know that students need to have access to healthy meals at school. Data shows that access to healthy meals increases academic performance, a sense of well-being, and focus in class. In addition, other benefits of providing universal free lunch, are:

- Reduction of hunger and food insecurity
- Eliminating stigma for those on existing free and reduced meals
- Removal of administrative burden of the processing of applications
- Promotion of student health by encouraging healthy eating habits and healthier meals.
- Creation of faster service by eliminating the time needed processing lunch tickets at check out, thus providing longer time for eating.

While it's true that the federal free and reduced lunch programs will remain for those that qualify, it's important to note that the federally provided free and reduced lunch program tests eligibility on a one-size-fits-all federal poverty standard. For 2022-2023, the earnings for a family of 4 could not total more than \$36,075 to qualify for free lunch (DESE website). Based on incomes here in Massachusetts, that threshold is not high enough to include all families who need assistance.

Given the rising costs of food, clothing, and shelter, across the Commonwealth, as well as the intense pressures on working families, this article is essential to alleviate at least some of the stress on our communities. The Commonwealth is one of the most expensive states in the nation to raise a family. This is causing many to leave the Commonwealth and our local area of Cape Cod and impacting the competitiveness of our economy. Identifying areas of need and ways to reduce these costs will alleviate the flight of families and ensure that the Commonwealth can recapture its investments in education. It is essential to provide healthy, nutritious meals for all of our students and to provide a sense of security for all of our families.

On May 16, 2023, the Wellfleet Selectboard held a public hearing that was advertised in the notice as "Jason Robicheau, The Grateful Mind ~ discussion on Community Host Agreement and the progress of his current licensing and final steps that need to be taken."

This notice did not specify that there would be a vote taken in which the Selectboard would decide on whether or not to approve the Community Host Agreement ("HCA") that had been negotiated between The Grateful Mind and the Wellfleet Town Administrator.

By using the term "discussion" in the description of the hearing within the meeting notice, the Selectboard failed to provide proper notice to interested parties, of which I am one.

Residing at 6 Commercial Street, Wellfleet, MA, an abutting property to the proposed location of The Grateful Mind, at 15 Bank Street, Wellfleet, I have an interest in the outcome of this meeting. Without adequate notice that the meeting would actually result in the board taking a vote on the HCA for the proposed cannabis business at that address, myself and other abutters and townspeople that are against siting this type of business in the central district of Wellfleet, were deprived of their right to make their position known.

Further, Mr. Robicheau's failure to seek a special permit from the ZBA for a recreational marijuana dispensary, as required by the Selectboard's own policy, effectively removed the ability for abutters and other town residents to voice concern over the proposed location of the dispensary.

What action do you want the public body to take in response to your complaint?

I request that the Selectboard strike the results of the vote taken during the May 16, 2023 meeting and reschedule Mr. Robicheau's hearing, ensuring that the notice provided adequately describes the actual scope of the meeting so interested parties may plan to attend and make their opposition known. I further request that the Selectboard refuse to entertain such a hearing until Mr. Robicheau can demonstrate that he has adhered to the Selectboard's policy of obtaining a special permit to operate a recreational marijuana dispensary from the ZBA.

Open Meeting Law Complaint from Charter Williams dated June 13, 2023

Dear Ms. Benedon:

Please be advised that this firm serves as Town Counsel to the Town of Wellfleet (the "Town"). The Town's Selectboard (the "Board") is in receipt of an Open Meeting Law Complaint (the "Complaint") filed by Mr. Charter Williams (the "Complainant"), dated June 13, 2023, which was received by the Town on June 15, 2023. The Complaint alleges that the Board violated the Open Meeting Law by taking a vote under an insufficiently detailed agenda item and by not requiring a special permit be obtained from the Town's Zoning Board of Appeals. A copy of the Complaint is attached hereto as Exhibit 1. The Board requested two brief extensions of time to respond to the Complaint from the Division of Open Government (the "Division"), which were granted on June 22, 2023 and July 12, 2023, respectively.

On July 13, 2023, the Board met in open session at a properly posted meeting to discuss the Complaint and consider its response. The Board has carefully reviewed the allegations contained in the Complaint and, following such discussion, has authorized this response on its behalf, in accordance with G.L. c.30A, §23 and 940 CMR 29.05(5), which is based upon information provided by the Town.

DISCUSSION

The Complaint does not allege any cognizable violation of the Open Meeting Law. First, pursuant to the Open Meeting Law, the Board properly listed discussion of the Host Community Agreement on its agenda. Second, the Complaint's allegations with respect to special permitting from the Zoning Board of Appeals do not invoke the Open Meeting Law.

I. The agenda was sufficiently detailed.

The Open Meeting Law was enacted "to eliminate much of the secrecy surrounding deliberations and decisions on which public policy is based." <u>Ghiglione v. School Committee of Southbridge</u>, 376 Mass. 70, 72 (1978). The Open Meeting Law specifically requires that "a public body shall post notice of every meeting at least 48 hours prior to the meeting, excluding Saturdays,

Sundays and legal holidays" and that "[n]otice shall be printed in a legible, easily understandable format and shall contain the date, time and place of the meeting and a listing of topics that the chair reasonably anticipates will be discussed at the meeting." G.L. c. 30A, § 20. The Attorney General's regulations further clarify that "[t]he list of topics shall have sufficient specificity to reasonably advise the public of the issues to be discussed at the meeting." 940 CMR 29.03(1)(a).

In the context of meeting agendas, "[t]he Board need not list each and every detail about a topic in order to comply with the [Open Meeting Law's] requirements. See OML 2019-134. More specifically, the Open Meeting Law "does not require a public body to anticipate the course of deliberation or the outcome of a discussion, only that it identify the discussion topic with sufficient specificity to reasonably advise the public of the issues to be discussed at the meeting." Id.; see G.L. c.30A, § 20(b); 940 CMR 29.03(1)(b). "The issue here...is not whether a vote was anticipated, but whether discussion of the topic was anticipated...." OML 2021-159.

Here, the agenda listed the following item under item IX. Business with specificity:

B. Jason Robicheau, The Grateful Mind ~ discussion on Community Host Agreement and the progress of his current licensing and final steps that need to be taken.

In accordance with the requirements of the Open Meeting Law, this agenda item for May 16, 2023 not only identified the proposed business as well as the name of the applicant, it also detailed the specific reason the Board would be discussing this business and applicant; namely, the review the proposed host community agreement and any "final steps that need to be taken." The public was given clear notice that The Grateful Mind's host community agreement was to be discussed at the Board's meeting, including "final steps" for approval. The Board's discussion at the meeting addressed such matter, with prior notice to members of the public who chose to attend. Indeed, the Board notes that individuals attending the May 16 meeting, including a member of the public, were recognized and spoke during the Board's discussion of such agenda item. Therefore, no actionable violation of the Open Meeting Law occurred.

II. No public hearing was required, and all other allegations are not germane to the Open Meeting Law.

The Complaint further alleges that "Mr. Robicheau's failure to seek a special permit from the ZBA for a recreational marijuana dispensary, as required by the Selectboard's own policy, effectively removed the ability for abutters and other town residents to voice concern over the proposed location of the dispensary." Ex. 1, at 2. Without waiving any of its rights relative to such allegations, the Board respectfully submits that such allegations fall outside of the scope of the Open Meeting Law, or the Division's review. See Division of Open Government, Frequently Asked Questions (Public Hearings).

Specifically, an allegation relative to special permit matters does not implicate provisions of the Open Meeting Law or the Division's review pursuant to such legal requirements. The provisions of G.L. c.30A, §23 state, in pertinent part, "Upon the receipt of a complaint by any person, the attorney general shall determine, in a timely manner, whether there has been a violation of the open meeting law" (emphasis added). The Division declines to review allegations that do not implicate the Open Meeting Law. See OML Declination January 25, 2016 (Nahant); OML Declination April 8, 2022 (Savoy). Here, the Complaint alleges that the Board erred in not requiring The Grateful Mind to secure a special permit. Ex. 1, at 2. The Board respectfully submits that such allegations do not implicate the requirements of the Open Meeting Law, thus the relief requested relative to such special permit matters from the Zoning Board of Appeals is not warranted.

CONCLUSION

Based on the foregoing, the Board respectfully submits that there has been no violation of the Open Meeting Law and as such, the Board considers this matter resolved.

 distributed it to the Mass Shellfish Officer's Assn. and AmeriCorps Cape Cod. It is also on
 the Town's website.
- As of June 1, and until Sept. 30, recreational shellfishing can only take place on Wednesdays and Sundays at the Indian Neck recreational-only shellfishing area. In addition, South Lieutenant Island is closed to oyster harvest. We changed out shellfish signs throughout town.
- We made a few seed confiscations in the recreational shellfishery and had a few who were using last year's permits and made them renew.
- We conducted our first grant inspection.
- On June 2, we began our cultch season which is still ongoing. We are grateful to the DPW staff for helping us at any time of day! We received our Chapter 91 license and Water Quality Certification for our cultching activities in the summer of 2022 (after our 2022 cultching operations were completed), so this is the first year where we are confined to cultching within our permitted areas. We buoy off new cultch areas every low tide we can, taking our GPS with us so we understand where the boundary lines are. We place our

Section 62 RECORDS OF LICENSED AREAS, LICENSES GRANTED,

TRANSFERS AND RENEWALS

Section 62. The aldermen, city council or selectmen shall keep in their offices plans showing all such licensed areas, and, in a book devoted to that purpose only, a record of each license granted and of all transfers or renewals thereof, which shall include the name and residence of the licensee or transferee, the dates of issue, transfer, renewal and expiration thereof, and a copy of the description of the licensed areas as the same appears in the license. Each license, and all transfers or renewals thereof, shall forthwith after the granting or approval thereof be transmitted by the board so granting or approving the same to the city or town clerk, who shall record the same in a book kept especially therefor in his office. The licensee or transferee shall within thirty days after such issue or approval pay to said clerk for each license or renewal issued or transfer approved one dollar for such recording, and for each license issued shall also pay four dollars as reimbursement of said city or town for the cost incurred in granting said license, a record of which payment shall forthwith be entered upon said record by said clerk, and such license, transfer or renewal shall not take effect until said fees are paid and entry thereof

made as aforesaid. Said records shall be open to public inspection at all reasonable times. Forms for such license and for the transfer or renewal of the same shall be provided by the aldermen, city council or selectmen at the expense of their city or town.

- (g) the Town Treasurer; and
- (h) the Town Collector.
- 5-4-3 Notwithstanding any provision of this Charter, MGL, or bylaws to the contrary, one person may be appointed to serve as both Town Treasurer and Town Collector, and in such instance this shall be deemed to be a single position.

Section 5-5 Responsibilities for Personnel Administration

- 5-5-1 The Town Administrator shall administer and enforce the Personnel Bylaw, Selectboard policies, collective bargaining agreements and bylaws.
- 5-5-2 The Town Administrator shall cause to be written, approve, sign, and maintain in an up-to-date file the job description of all appointed positions under the direction of the Selectboard or Town Administrator. The Town Administrator shall maintain in said file an up-to-date listing of approved job descriptions of all appointed positions under the direction of other elected officers and committees.

Section 5-6 Responsibilities for Administrative Reorganization

5-6-1 The Town Administrator may, with the approval of the Selectboard, establish, reorganize, consolidate, or abolish any positions under the Town Administrator's direction and supervision, except as otherwise provided by MGL and this Charter.

Section 5-7 Department of Public Works

5-7-1 Deleted <date of 2019 ATE>.

Section 5-8 Removal

- 5-8-1 The Selectboard may initiate the removal of the Town Administrator by adopting a resolution to that effect, stating the reasons therefor, provided that no such resolution shall be adopted within sixty days following any Town election that has resulted in a change in the incumbents on the Board.
- 5-8-2 The adoption of said resolution shall serve to suspend the Town Administrator for a period of not more than forty-five days, during which the salary shall continue to be paid. A copy of the resolution shall be delivered forthwith to the Town Administrator in person, or sent by registered mail to the Town Administrator's place of residence.
- 5-8-3 Within ten days following the adoption of such resolution, the Town Administrator may file a written request for a hearing. If such a hearing is requested, the Selectboard shall schedule it within three weeks of such filing. The Selectboard shall advertise the hearing in a newspaper of local or regional circulation and shall cause notices citing the purpose, location, time, and date to be posted in the Town Hall and in two or

Dear Selectboard members,

While reviewing paperwork for a couple of the grant renewals for your meeting on July 13, 2023, I realized that some of them were for acreage in excess of the seven-acre limit established in our regulations.

Here are the relevant sections from the Town of Wellfleet Shellfishing Policy and Regulations:

7.8.6. Limit on Size of Grant

No licensee shall hold a license for, or have use of, more than seven (7) acres in total. Each person named on a license as a licensee shall be charged with the total acreage covered by that license. (See Section 7.3 <u>Annual License Fee.</u>) Individuals holding more than seven (7) acres prior to the adoption of the establishment of this limit will not be required to accept a license for a lesser acreage, but will not be eligible for a license for any additional acreage.

7.8.7. Grants Established Before August 1, 1993

Any license/s issued prior to August 1, 1993, the date on which the Selectboard established the maximum size of seven (7) acres for an aquaculture holding, will remain valid, and will be allowed to continue according to the existing terms and conditions of said license.

The Shellfish Department conducted a lot of research into this. As part of that research, we found that not only were there two renewals in front of you now, Jeremy Storer and Brent Valli-Sandra Mitchell, in excess of the seven acre limit, but that we have a handful of other families who also hold licenses for more than seven acres:

- 1. Brent Valli and Sandra Mitchell (husband and wife)
- 2. Aaron Francis (put on by his uncle David on a grant licensed to his grandfather Joe before David)
- 3. Irving Puffer and Jacob Puffer (father and son)
- 4. Tobin Storer, Kelly Ruml and Jeremy Story (father and mother and son)
- 5. Bob Wallace and John Wallace (father and son)

While the older generation may fall into the category defined by Section 7.8.7, none of the younger generation of license holders were added before August 1, 1993.

- 1. Brent Valli and Sandra Mitchell were added to each other's grants totaling 5.46 and about two acres on 1/27/2003.
- 2. Aaron Francis was added on 11/25/2003 to his uncle's one grant equal to 8.5 acres.



- 3. Jacob Puffer was added on 11/14/2006 to his father's two grants consisting of 10.21 and 5.48 acres.
- 4. Jeremy Storer was added to his father's two grants totaling nine acres on 11/22/2011 and was added to his mother's three grants totaling an additional approximate 4.16 acres on 5/24/2016.
- 5. John Wallace was added to his father's three grants totaling 2.29 and five acres on 12/24/2014.

Upon pulling the above files from the Town Hall records (using a sign out sheet and replacing them when we had finished our review), we conducted painstaking research going back into the minutes of each of the Selectboard meetings for transfers and renewals. We found a precedent that the Selectboard set with the Valli-Mitchell shellfish grant situation at its 1/27/2003 public hearing. (See minutes attached with highlighting.)

At that meeting, the Selectboard granted Brent and Sandra a waiver to allow them to hold shellfish grant licenses in excess of seven acres. While we did not find the same waiver notes in other Selectboard public hearings, we feel that the precedent was set for these specific family situations.

We also conducted additional research into the language of Section 7.8.7, where it is states that ANY LICENSE ISSUED prior to August 1, 1993, ... will be allowed to continue ACCORDING TO THE EXISTING TERMS AND CONDITIONS OF SAID LICENSE.

In all shellfish grant licenses, the following terms are stated:

"This license is transferable only in conformity with the provisions of Chapter 130 and with approval in writing of the Selectmen."

Chapter 130 places no acreage limits on holding shellfish grant licenses, and the Selectboard clearly approved the original transfers and subsequent renewals of these licenses year after year, so this seemed to validate that the exceeding of acreage in the above specific family instances has not been an issue for the Selectboard in the past.

I will admit that in 2018, I oversaw the renewal of the Puffer's two shellfish grant licenses for 15.69 acres, and in 2020, I put forth renewals for Francis's license for 8.5 acres and Valli-Mitchell's renewals for three grants consisting of 3.46 acres, and I never realized that this was an issue, perhaps assuming some sort of "grandfathering."

Upon conferring with my colleagues, Johnny and Chris, we would recommend that moving forward, a motion for a waiver on acreage is done as part of the renewals for these five specific family situations and the grant holders as they are currently licensed.

Board of Selectmen Library Meeting Room January 27, 2003 Minutes

The meeting was called to order at 7:00 p.m. by Chairman Roger L. Putnam, Jr. Selectmen present included Michael May, Dale Donovan, Michael Parlante and Jerry Houk. Town Administrator Tim Smith also attended.

Open Session:

Margo KochRuthe addressed the Board regarding her October 28th request for a letter of assurance from the Board that the matter of the
"junk yard" in her neighborhood would be addressed by the Town. The Town Administrator updated the Board on the status of this matter
and will forward a letter to Ms. KochRuthe outlining the Town's efforts to date.

On a motion by Parlante, seconded by Donovan, the Board voted 3-0-2, with May and Houk abstaining (May had not attended the 1/13 meeting and Houk had not attended either meeting) to approve the minutes of January 9 and January 13, 2003.

On a motion by Parlante, seconded by May, the Board voted unanimously to release the executive session minutes dated 10/7/94, 9/19/94, 9/12/94, 8/29/94, 8/29/94, 8/1/94, 7/25/94, 7/18/94, 6/13/94, 6/6/94, 5/31/94, 5/16/94, 5/8/94.

The Town Administrator reminded the Board of its final budget meeting scheduled for February 5th at 7:00 p.m. in the Library Meeting Room to meet with school officials.

Selectmen's Comments/Reports:

- Selectman Houk 1) noted that Warren Rhodes had passed away and suggested that a letter be drafted to Judy Rhodes. On a motion by Donovan, seconded by Putnam, the Board voted unanimously that the Clerk of the Board draft a letter to Ms. Rhodes for signature by all Board members; 2) commented on the status of the Public Safety Review Committee noting that he felt that
 - Selectman Donovan commented on the memo to the Planning Board from the Assistant Town Administrator indicating that the Board is
 asking for consideration of a specific Town Meeting article noting that the article has not been discussed by the Board. The Town
 Administrator will follow up on this matter.

The Board met with Paul Ruchinskas, Affordable Housing Specialist of the Cape Cod Commission, regarding allocations and guidelines for the \$500,000 affordable housing allocation from Barnstable County. Mr. Ruchinskas outlined rental housing development subsidies, the purchase pool program, technical assistance to the towns and program guidelines noting that applications were available as of January 2, 2003.

The Board held the following Shellfish Department public hearings consecutively. Selectman Parlante recused himself. Selectman Donovan read the public notice. Shellfish Constable Bill Walton was in attendance and presented his recommendations to the Board.

a) Application from Brent Valli for transfer of shellfish grant licenses #781A, #781B and #781AC located at Egg Island and consisting of 5.5 acres from Brent Valli to Brent Valli and

- Sandra Mitchell and the application from Sandra Mitchell for transfer of shellfish grant licenses #95-21 and #95-22 located at Egg Island and consisting of 1.8 acres from Sandra Mitchell to Sandra Mitchell and Brent Valli the Shellfish Constable recommended that this transfer be approved on the condition that Mr. Valli amend license #781AC (currently awaiting paperwork from the Army Corps of Engineers) prior to final approval by reducing the area by .3 acres so that these applicants will not be in violation of the Wellfleet Shellfishing Policy and Regulation section 5.1.7, which states that no individual may hold more than 7 acres and that approval of this transfer be pending finalization of shellfish grant license #781AC. Brent Valli requested that the Board consider a waiver and not require that the grant license area be reduced by .3 acres because a considerable amount of paperwork would have to be refiled and the area proposed by the Shellfish Constable would not be useful to anyone else On a motion by Donovan, seconded by Houk, the Board voted unanimously 4-0 to grant a waiver to Mr. Valli and Ms. Mitchell and to approve these transfers per the recommendation of the Shellfish Constable.
- b) Application from Wentzle Ruml IV for renewal of shellfish grant licenses #95-13, #95-14 and #2000-4 located at Egg Island and consisting of approximately 4 acres the Shellfish Constable recommended that these licenses be renewed as follows: #95-13 and #95-14 for a period of 10 years ending on March 1, 2013 and #2000-4 for a period of 5 years ending on March 1, 2008. On a motion by Houk, seconded by Donovan, the Board voted unanimously 4-0 to approve renewal of these grant licenses.
- c) Application from Richard Bartke for renewal of shellfish grant license #00-10 located at Indian Neck and consisting of 3 acres the Shellfish Constable recommended that this license be renewed for a period of 5 years commencing on the expiration date of December 18, 2002 and ending on December 18, 2007. On a motion by Houk, seconded by May, the Board voted unanimously 4-0 to approve renewal of this grant license.
- d) Application from Richard Goldberg for renewal of shellfish grant license #01-08 located at Indian Neck and consisting of .5 acre the Shellfish Constable recommended that this grant license be renewed for a period of 5 years ending on September 19, 2008. On a motion by Houk, seconded by May, the Board voted unanimously 4-0 to approve renewal of this grant license.
- e) Application of James Falcone for renewal of shellfish grant license #01-01 located at Lt. Island and consisting of 1 acre the Shellfish Constable recommended that this grant license be renewed for a period of 5 years ending on February 15, 2008. On a motion by Houk, seconded by May, the Board voted unanimously 4-0 to approve renewal of this grant license.

Selectman Michael Parlante rejoined the Board.

f) Consideration of amendment of Section 8.1.4 of the Wellfleet Shellfishing Policies and Regulations by adding as the final sentence "A violation of this regulation shall exist if the take contains more than 5% seed shellfish." - the Shellfish Constable presented his recommendation that the words "per batch" be added to the end of this section and that any seed found should be returned to the waters of the Harbor. Shellfish Advisory Committee Chair Chris Merl indicated that the Committee had voted to approve the Constable's recommendations. On a motion by Donovan, seconded by Parlante, the Board voted unanimously to amend Section 8.1.4 of the Wellfleet Shellfishing Policies and Regulations by adding the following last sentence: "A violation of this regulation shall exist if the take contains more than 5% seed shellfish per batch (see sec. 11.1.3)."

Selectman Donovan presented his correspondence report noting that anyone interested in serving on the Citizen's Police Academy starting on March 20th should call the Police Department.

The Board discussed:

- Water Issues there was consensus to schedule this discussion for a meeting as Water Commissioners on February 3rd in the Library Meeting Room with members of the Water Issues Advisory Committee and Board of Health.
- 2) Business Licenses Selectman Parlante recused himself. Donovan moved and Houk seconded a motion to approve the business licenses as printed on the agenda. (Down Under Video; Boathouse Fish Market; Wellfleet Marine Corp. (booth); Wellfleet Marine Corp. (pier store); Southfleet Motor Inn) Selectman May noted the conditions indicated by the Harbormaster on Wellfleet Marine Corp's (booth) license application ("Strike from line #7 'Mooring Rentals', want copies of launch tenders licenses for those that apply). The Board voted unanimously to approve these licenses as conditioned by the Harbormaster. Selectman Parlante rejoined the Board.
- 3) Auditor Recommendation the Town Administrator requested that this matter be postponed to the February 10th meeting of the Board.
- 4) Senior Center Change Order the Town Administrator explained that the \$13,000 change order is necessary to upgrade the fire code in the main room and corridors in order to increase the capacity of the new Senior Center building. On a motion by Donovan, seconded by Parlante, the Board voted unanimously to approve the Senior Center change order as outlined by the Town Administrator.

- 8) Contract for Bath House Feasibility Study the Town Administrator recommended that the Board contract with Bourne Engineering for the Shellfish building bath house project. On a motion by Parlante, seconded by May, the Board voted unanimously to contract with Bourne Engineering to perform a feasibility study and concept design for the shellfish building in the amount of \$7,300.

On a motion by Houk, seconded by May, the Board voted unanimously to adjourn at 8:19 p.m.



I received an application on 05/05/2023 from Jeremy Storer (Wellfleet, MA) and Alfred Pickard (Wellfleet, MA) for the renewal of shellfish grant license #2000-4 consisting of 2.16 acres on Egg Island for ten years, one month and 29 days, beginning March 1, 2023, and expiring April 30, 2033.

I reviewed last year's annual grant report for #2000-4 and compared it with the grant inspection we conducted to ensure this grant was meeting minimum production requirements. Alfred planted 100,000 field plant quahogs there last year, which is an investment that we consider making minimum productivity. We understand that he has already planted more quahogs there this month. We will continue to monitor this.

FROM WELLFLEET SHELLFISH POLICY AND REGULATIONS

SECTION 1: DEFINITIONS

Aquaculture License - An authorization, granted by a vote of the Board of Selectmen, to utilize a specific tract of land, under coastal waters (1) to plant and grow shellfish using in-bottom or off- bottom culture; (2) to place shellfish in or under protective devices affixed directly to the tidal flats or land under Wellfleet's coastal waters, such as boxes, pens, trays, bags or nets; (3) to harvest and take legal shellfish; (4) to plant cultch for the purpose of catching shellfish seed; and (5) to grow shellfish by means of racks, rafts or floats (MGL Chapter 130; Section 57). Licensed Area (Grant) - a designated bottom area, certified by the Division of Marine Fisheries (DMF) and licensed by a vote of the Board of Selectmen, on which the licensee may plant, grow and harvest shellfish (MGL Chapter 130; Sections 57 & 68).

<u>Resident</u> - A declared resident of the Town of Wellfleet. Written proof that Wellfleet is the domicile as well as the legal residence of the applicant shall be required to the satisfaction of the Shellfish Constable and Board of Selectmen. Domicile will be established after one year of residency in Wellfleet is demonstrated. Proof of legal residence may include voter registration, automobile registration, driver's license, income tax filings, census data, or passport.

7.8. Issuance of Licenses for Aquaculture

7.8.1. Eligibility Requirements: Licenses shall only be issued to domiciled residents (See Sec.1 Definitions) of the Town, 18 years of age or older, who have the knowledge and experience to fulfill the responsibilities specified in the license, provided that the applicant has held and been documented by the Shellfish Department using a Wellfleet commercial shellfishing permit during a period of at least three (3) of the four (4) calendar years preceding the date of application for a license. Applicant shall submit copies of state-filed catch reports. OR, provided the applicant demonstrates experience in shellfish propagation and aquaculture, continuously, over at least three (3) years preceding the date of application, documented by the Shellfish Department. This shall be supported by a letter from a license holder who employed the applicant describing the type of work performed and any other information which might be relevant. The applicant shall present a detailed five-year business plan for how s/he intends to use the grant, including shellfish species, amounts and sizes, and gear to be used, access routes and any other information relevant to proposed operations. In addition, any applicant shall not show a pattern of violations of Wellfleet's Shellfishing Policy and Regulations within the last three (3) years.

At such time as a licensee ceases to be a domiciled resident of the Town that individual shall be removed from the license. The status of all other licensees will not change. If that licensee is the sole licensee then the license shall be revoked.

Dear Selectboard members:

I received an application on 6/29/2023 from Michael DeVasto (Wellfleet, MA) and Michael Ramsdell (Wellfleet, MA) to transfer shellfish grant licenses #855 and #855B consisting of a total of approximately two acres on Field Point from Michael DeVasto and Michael Ramsdell to Michael DeVasto and Kathleen Murphy (Wellfleet, MA).

I received another application on 6/29/2023 from Michael DeVasto to transfer shellfish grant license #855C consisting of a total of approximately 1.6 acres on Field Point from Michael DeVasto to Michael DeVasto and Kathleen Murphy.

I reviewed the annual grant reports for #855 and #855B and compared them with the grant inspections we conducted to ensure these grants were meeting minimum production requirements. These two grants demonstrate abundant shellfish farming; there is no question about them exceeding minimum productivity. All the permitting and certifications for grant #855C was completed in 2022, so this grant extension is being farmed in 2023. We positioned the buoys together using the Shellfish Department's GPS in the spring, and a professional survey is scheduled for the fall. There is visible shellfish production in the extension already this year.

I reviewed Michael DeVasto's state propagation and commercial shellfishing permits, and they are in good standing. I reviewed Kathleen's state commercial shellfishing permit, and she is also in good standing. I am hopeful that you have taken the Shellfish Department's previous recommendation and will allow us to issue her a Town commercial shellfishing permit.

Katie has more than a decade of experience in shellfish farming on these grants and meets every requirement set out in our regulations except the newly required Town commercial shellfishing permit for grant holders. We firmly believe that it was not the intention of the Selectboard when it introduced a new revenue stream last December to exclude potential new grant holders from being added to grants in the interim months when commercial shellfishing permits are not on sale.

In addition, when you invoked a moratorium on grant transfers at your April 18, 2023, meeting, you specified it to "non-natural" persons only, which makes us believe that you intended to allow natural person, domiciled residents of Wellfleet to continue to be able to be transferred onto shellfish grant licenses.



Here is the motion from your 4-18-23 meeting minutes online:

"Chair Curley Moved; Board Member Bacon Seconded; and it was voted to establish a moratorium on the transfer of shellfish licenses as stated in Section 7.7 relative to one of the transferees is a non-natural person until September 30, 2023, including a finding that this action is appropriate in the best interest for the fishery and the environment."

I have conferred with Johnny and Chris who agree with the recommendation to transfer shellfish grant license #s 855 and 855B from Michael DeVasto and Michael Ramsdell to Michael DeVasto and Kathleen Murphy, and to recommend transferring shellfish grant license #855C from Michael DeVasto to Michael DeVasto and Kathleen Murphy.

At such time as a licensee ceases to be a domiciled resident of the Town that individual shall be removed from the license. The status of all other licensees will not change. If that licensee is the sole licensee then the license shall be revoked.

Dear Selectboard members,

First, Rebecca Taylor submitted paperwork to remove her dad, Myron Taylor's name from shellfish grant license #s 734 and 734A because he is retiring. Although I am sad to see him retire, I recommend that shellfish grant #s 734 and 734A be transferred into Rebecca's name alone. Please join me in commending Myron Taylor for his long career on the water and the help he has given the town with his research and observations of the natural world given his decades of experience shellfishing in Wellfleet Harbor.

Second, as you know, the Shellfish Department has been working with Rebecca Taylor and Angela Osowski to find a compromise for a grant extension between their respective grants on Mayo Beach.

I received a revised application for two grant extensions from Rebecca Taylor on June 29, 2023. The first proposed revised grant extension would be numbered 734B, which would be an altered configuration from what you approved at your March 21, 2023, meeting. It will now NOT include the area between the Taylor and Osowski grants and will only incorporate the area on the offshore side of grants 734 and 734A, consisting of approximately 0.61 acres on Mayo Beach.

The second proposed extension, to be called 734C, is on the inshore area of grants 734 and 734A, consisting of 0.79 acres on Mayo Beach. The new configuration allows Osowski's request for an extension to grant #99-1 to be located mostly where she had originally asked for it and provides for a 10-foot buffer to be used as a driveway between grant #s 734A and 99-1 Ext. Attached please find the grant extensions application and associated maps.

I reviewed Rebecca's state propagation and commercial shellfishing permits to make sure they were in good standing. We reviewed their annual grant reports and compared them with the grant inspections we conducted, and all is going well. On June 9, 2023, we conducted a site visit with Harbormaster Will Sullivan and Director of Community Services (for the Beach Dept.) Suzanne Grout Thomas. Neither had any concerns about the location of these proposed shellfish grant extensions.



We greatly respect the time and effort that both Rebecca Taylor and Angela Osowski have invested into finding this compromise, and we are completely supportive of it. We recommend that you approve these grant extension requests.





Dear Selectboard members,

As you know, the Shellfish Department has been working with Rebecca Taylor and Angela Osowski to find a compromise for a grant extension between their respective grants on Mayo Beach.

I received a revised application for a grant extension from Angela Osowski on May 26, 2023, on behalf of her and Robert and Mary Mallory. The proposed revised grant extension would be numbered 99-1 Ext. and consists of approximately 0.35 acres on Mayo Beach in the general area where they had proposed it before but allowing for a driveway buffer between the extension and Taylor grant #s 734A and 734B. Attached please find the grant extension application and associated maps.

I reviewed their state propagation and commercial shellfishing permits to make sure they were in good standing. Robert and Mary Mallory do not have propagation permits, but Angela Osowski does, and that is enough. Angela and Robert have all their commercial shellfishing permits in order, and Mary is coming to you with a hardship exemption request for hers. She does have a state shellfishing permit already.

We reviewed their annual grant reports and compared them with the grant inspections we conducted, and all is going well. On June 9, 2023, we conducted a site visit with Harbormaster Will Sullivan and Director of Community Services (for the Beach Dept.) Suzanne Grout Thomas. Neither had any concerns about the location of this proposed shellfish grant extension.

We greatly respect the time and effort that both Rebecca Taylor and Angela Osowski have invested into finding this compromise, and we are completely supportive of it. We recommend that you approve this grant extension request.

They will then need to go through the rest of the permitting and certification process for this new grant with the Mass. Division of Marine Fisheries, Wellfleet Conservation Commission, Army Corps of Engineers, etc.

Dear Selectboard members.

I received an application on May 26, 2023, from Stephen Pickard, Iris Pickard and Benjamin Pickard requesting a shellfish grant license extension on Egg Island (to be called #2000-2 Ext), totaling approximately 1.23 acres. This is an extension that had previously been approved by the Selectboard on March 11, 2002. However, the paperwork was never completed, and the Mass. Division of Marine Fisheries said that they would have to begin again, which is what they are now doing.

With the current application, the Pickards have gone back to the original configuration of the extension approved in 2002 as opposed to the revised configuration that was presented to the Selectboard earlier this year due to feedback from the Harbormaster about its proximity to the channel. At this point, they feel they would like to try taking advantage of the depth of the grant to test some new techniques that could possibly mean less labor.

Stephen met independently with both the Harbormaster and me to explain why he had reincluded the area by the channel. He said he believes that that deeper water area will be better for growth of quahog seed using trays due to the currents flushing food by and the fact that it rarely comes out of the water, which means that seed quahogs can feed continuously. He said he also would be trying to overwinter oysters in harvest bags to keep them accessible for sale yet secured below any potential for exposure to the elements or ice. Both the Harbormaster and I agreed that this seemed like a well thought-out use of the deep water area that would not present conflicts with boaters, kayakers, etc. because of the depth of the grant where the gear would be. Stephen indicated that they will put out more than the four corner buoys in order to accurately mark the channel.

All three applicants are current grant holders with propagation permits in good standing. I have compared annual grant reports for 2000-2 to our annual grant inspections and have determined that their current grant meets minimum productivity. Adding 1.23 acres to their current 1.5 acres doesn't put them over the seven-acre limit. Each of them has both state and town commercial shellfishing permits.

Quahog runs take up real estate for years, so I understand from a business perspective why they need to expand their operations. I recommend that you approve this grant extension. Attached is the complete application and maps.



FROM WELLFLEET SHELLFISH POLICY AND REGULATIONS

SECTION 1: DEFINITIONS

Aquaculture License - An authorization, granted by a vote of the Board of Selectmen, to utilize a specific tract of land, under coastal waters (1) to plant and grow shellfish using in-bottom or off- bottom culture; (2) to place shellfish in or under protective devices affixed directly to the tidal flats or land under Wellfleet's coastal waters, such as boxes, pens, trays, bags or nets; (3) to harvest and take legal shellfish; (4) to plant cultch for the purpose of catching shellfish seed; and (5) to grow shellfish by means of racks, rafts or floats (MGL Chapter 130; Section 57). Licensed Area (Grant) - a designated bottom area, certified by the Division of Marine Fisheries (DMF) and licensed by a vote of the Board of Selectmen, on which the licensee may plant, grow and harvest shellfish (MGL Chapter 130; Sections 57 & 68).

<u>Resident</u> - A declared resident of the Town of Wellfleet. Written proof that Wellfleet is the domicile as well as the legal residence of the applicant shall be required to the satisfaction of the Shellfish Constable and Board of Selectmen. Domicile will be established after one year of residency in Wellfleet is demonstrated. Proof of legal residence may include voter registration, automobile registration, driver's license, income tax filings, census data, or passport.

7.8. Issuance of Licenses for Aquaculture

7.8.1. Eligibility Requirements: Licenses shall only be issued to domiciled residents (See Sec.1 Definitions) of the Town, 18 years of age or older, who have the knowledge and experience to fulfill the responsibilities specified in the license, provided that the applicant has held and been documented by the Shellfish Department using a Wellfleet commercial shellfishing permit during a period of at least three (3) of the four (4) calendar years preceding the date of application for a license. Applicant shall submit copies of state-filed catch reports. OR, provided the applicant demonstrates experience in shellfish propagation and aquaculture, continuously, over at least three (3) years preceding the date of application, documented by the Shellfish Department. This shall be supported by a letter from a license holder who employed the applicant describing the type of work performed and any other information which might be relevant. The applicant shall present a detailed five-year business plan for how s/he intends to use the grant, including shellfish species, amounts and sizes, and gear to be used, access routes and any other information relevant to proposed operations. In addition, any applicant shall not show a pattern of violations of Wellfleet's Shellfishing Policy and Regulations within the last three (3) years.

At such time as a licensee ceases to be a domiciled resident of the Town that individual shall be removed from the license. The status of all other licensees will not change. If that licensee is the sole licensee then the license shall be revoked.


