#### ARTICLE 23: Commercial Single-Use Plastic Water Bottle Ban.

To see if the Town will vote to adopt the following as a general by-law and to insert it into the Code of the Town of Wellfleet, Massachusetts.

#### Section 1. Sale of Single-use Plastic Water Bottles

Effective on September 1, 2021, it shall be unlawful to sell non-carbonated, unflavored drinking water in single-use plastic bottles of less than one gallon in the Town of Wellfleet. Enforcement of this regulation will begin September 1, 2021.

#### Section 2. Definitions

A single-use plastic bottle is a beverage container made from any type of plastic resin.

#### **Section 3. Exemptions**

Sales or distribution of non-carbonated, unflavored drinking water in single-use plastic bottles occurring subsequent to a declaration of emergency (by the Emergency Management Director or other duly authorized Town, County, Commonwealth or Federal official) affecting the availability and/or quality of drinking water to residents of the Town shall be exempt from this bylaw until seven days after the declaration has ended.

#### Section 4. Enforcement

Enforcement of this article shall be the responsibility of the Town Manager or his/her designee. The Town Manager shall determine the inspection process to be followed, incorporating the process into other Town duties as appropriate.

Any establishment conducting sales in violation of this article shall be subject to a non-criminal disposition fine as specified in G. L. Chapter 40 21D. The following penalties apply:

• First violation: Written warning

• Second violation: \$150 fine

• Third and subsequent violations: \$300 fine

Each day a violation continues constitutes a separate violation, incurring additional fines. Any such fines collected shall be payable to the Town of Wellfleet.

All businesses will be routinely inspected until the Town Manager deems the inspection to no longer be required.

**Selectboard**: Reserves recommendation. **Recycling Committee**: Recommends 0-0.

Bylaw Committee: Recommends 2-0 with the following amendment:

Change Section 4 to replace Town Manager with Town Administrator in the three places it is listed.

**SUMMARY**: Single-use plastic bottles impact environmental health, and the health and longevity of other species, who may ingest plastic as food. Ultimately, plastic re-enters the human food chain where the adverse consequences are both known and emerging. Plastics pollute and impact our environment across their lifecycle from production to use to disposal.

Over 1,500 single-use plastic water bottles are used and discarded in the U.S. per second. Elimination of the use of single-use plastic water bottles will have a significant impact on future plastic-based pollution including the nation's greenhouse gas footprint and is consistent with protection of the natural

environment in Wellfleet, Barnstable County, our nation and our earth, which we have a common responsibility to protect and steward.

#### ARTICLE 25: Proposal to Amend Town of Wellfleet General Bylaw.

To see if the Town will vote to adopt the following as a general bylaw and to insert it into ARTICLE VII of the By-laws of the Town of Wellfleet, Massachusetts as Section 39:

#### Section 39 Climate Policy

The Town of Wellfleet recognizes that the climate emergency, driven by human activity including energy consumption and land use practices and leading to global warming, rising seas, deadly storms, dangerous heat waves, acidifying oceans, and melting ice sheets, poses an imminent threat to the health, safety and economic security of the residents of the Town. The Town of Wellfleet therefore adopts as its policy the objective of reducing net greenhouse gas emissions from human activity within and by the Town to zero at the earlies technically and economically feasible time, and directs that all officers and departments of the Town take such measures within the scope of their respective responsibilities and authority as may be necessary and prudent to facilitate such policy and objective.

#### Majority vote required.

(Petitioned Article)

**Selectboard**: Reserves recommendation 4-0-1. **Bylaw Committee**: Does NOT recommend 2-0.

Recycling Committee: Recommends 0-0

ARTICLE 27: Disposition of Town Land to Conservation Commission. To see if the Town will vote to transfer care, custody, management and control of Assessors Map 20, Parcels 11, 12, and 16, Town owned properties along Kendrick Avenue from the board or commission currently having custody thereof and from the purpose for which said property is currently held, to the Wellfleet Conservation Commission for open space purposes, or to do or act anything thereon.

Two-thirds vote required.

**Selectboard**: Recommends 4-0-1

Open Space Committee: Recommends 0-0.

Planning Board: Recommends 5-0.

Conservation Commission: Reserve recommendation until town meeting.

Natural Resources Advisory Board: Recommends 5-0.

**SUMMARY**: These three properties are located west of Mayo Beach and are each classified as Coastal Dune, Coastal Beach and Barrier Beach. They contain 1.84 acres and are all within the Areas of Critical Environmental Concern (ACEC) and the Flood Zone.

Re: Contingent articles and ballot questions

At the time of writing this memo, the outcome of Tuesday's election is unknown. But here are some things to consider if some of the questions don't pass.

- Why was the election scheduled before the Town Meeting? The Town Clerk refreshed
  my memory today that this was the result of the legislature not taking any action to
  modify MGL Ch 59§21C(m), which requires that "...no election at which the question
  appears on the ballot shall take place later than the September 15 following the date of
  an appropriation vote adopted at an annual town meeting...".
- This was not brought to her attention until after we had decided on the dates (including rain dates) for Town Meeting. Had we all been more aware of this constraint, perhaps the Board could have included a Special Town Meeting within the regular meeting, which would then have permitted an election within 90 days following the meeting.
- Regardless of whether the ballot questions pass or fail, the articles are still properly
  before the voters and can be acted on. If one or more of the articles pass at Town
  Meeting, another special election could be called, assuming Town Counsel and bond
  counsel agree that even though this is our Annual Town Meeting, it might be considered
  a Special Town Meeting for such articles and election. I don't know whether this would
  pass muster with the attorney general, bond counsel or others who decide on these
  matters. There is also still the challenge and cost of scheduling yet another election
  during a busy fall election calendar.
- Ultimately, it's up to the Board (or to other proponents) whether to move these articles on Saturday, or to move for indefinite postponement those which did not pass at the election. Noting that the 2021 ATM is only about 7-1/2 months away (hoping we can meet normally by then), indefinite postponement might be the best course of action.

#### Dan and Courtney,

I agree with you regarding the consent calendar. First, ask Town Meeting to approve considering the selected articles as a group, and if that motion passes, then entertain a single motion to approve all of those articles in the group.

Art. 29: Articles granting an easement typically include a plan to give members a general idea of where the easement is to be located, and the warrant does direct folks to the sketch plan. Whether it is a single page or four does not matter. If the date of the plan is wrong in the warrant, then we should correct this in the motion, but it might be that the sketch is dated August 18, 1987 but then was approved (perhaps by the BOH?) a month later on September 10, 1987. Let's confirm once we see a copy of the sketch.

Art. 30: I will look for the email with the plan. As for the explanation, accepting a road as a town road has specific statutory steps, including the Selectboard sending notice to owners of property abutting the way of the Board's intent to accept the road as a town road followed by a meeting at which the Selectboard actually vote to adopt the layout, which is the plan of the road to be accepted, showing the metes and bounds of the road. This layout plan must be accepted by the Selectboard and then filed with the Town Clerk, where it must remain in file for at least 7 days prior to Town Meeting's vote to accept the road. Where we do not have a record of the Selectbord sending out notices, having the meeting or voting to adopt the layout plan, it appears the statutory process was not followed, and therefore, the article should be postponed until the process can be perfected.

I will look for the email with the plan now.






