Superintendent as to approval or disapproval of such proposed change orders. Final decision on such change orders shall be at the discretion of the Superintendent. (Possible alternative: change orders of up to \$ \_\_\_\_\_ may be approved by the School Building Committee, acting on behalf of the School Committee, after consultation with the Superintendent).

Change orders of \$25,000.00 or less may be approved by the Superintendent or by \_\_\_\_\_ without first seeking the recommendation of the school Building Committee.

In the event of an emergency which requires action on a change order in excess of \$25,000, the Superintendent or \_\_\_\_\_ has the power to approve the same without first seeking the recommendation of the School Building Committee, provided however, that such person will seek the input of the School Committee Chair before approving additional funds.
