Herring River Estuary

- The Gut (4)
- Fisherman’s Landing (5)
- Dike (North & South) (6a & b)
- Sand Pullout - off Chequessett Neck Road, 19-103 (Privately owned)
- Chequessett Neck Yacht Club – privately owned 19-115, never a town landing. Adjacent lot 19-114 lost (7)

Town Beaches

- Power’s Landing (8)
- Mayo Beaches A-F (including Keller’s Corner (A)) (9-14)
- L-Pier *
- Marina Boat Ramp
- Finger Piers*

**Landings are not on accompanying map due to space.*

Duck Creek

- Condos; not in Echeverria Rpt. but used frequently. The entire lot is 21-116-(A-P); however, each individual condo is owned separately (A through P). Vacant during winter months.
- Bank St. Parking Lot (Old Fire Barn) (16)
- Pine Point Road/Railroad Bridge; not in Echeverria Rpt. but used frequently.
- Old Cahoon Hollow (Pine Point Way) (21)
- Richman Lane; 21-30-1 Privately owned; owner allows parking on right and use only of path straight out from lot.

Chipman’s Cove

- End of Nauhaught Bluffs Rd; not in Echeverria Rpt. but frequently used. Privately owned 21-9-1; vacant during winter months.
- Old Pier Road (22)
- Chipman’s Cove Southeast; small path on map 28-26 at Cove View – not in Echeverria Rpt. but frequently used. Privately owned.
- Spence Way; not in Echeverria Rpt. but frequently used. Privately owned 28-40, vacant during winter months.
- Chipman’s Cove Southwest – side of Nauset road 28-41 (WCT)
- Chipman’s Cove West; access from Indian Neck parking lot; south end of 22-38

Indian Neck

- Whitman's (Aquaculture Access); 22-23 (23)
- Indian Neck Beach (Breakwater Landing in Echeverria Rpt.) (23)
- Dune Path (Middle Pass)
- Burton Baker Beach (24)
- Hiawatha Road (Foot only)
- Omaha (Aquaculture Access); Privately owned, town is abutter (Lot 28-234)

Blackfish Creek

- Fox Island marsh; (MA Div. of Fish & Wildlife)
- Paine Hollow (26)
- Pleasant Point (27)
- Mound St. Landing (in Echeverria Rpt.) "Town way to Water" signage in place. (29)
- MIA Memorial Park (30)
- Cannon Hill Beach; Long Ave. to Water St. to end of First Ave.; leads to town owned lot 30-188 (35)

Drummer's Cove

- Water St Landing; Privately owned, in the area of 30-131, 120, and 119. Not in Echeverria Rpt. but used by both recreational and commercial shellfishermen at times.

Old Wharf Point

- WCT/Audubon Access (Right of Old Wharf Rd)
- Old Wharf Road Landing (36)
- End of Old Briarcliff; Old Try Works in Echeverria Rpt. (37)

Lieutenant Island

- Compass Rd 41-64; Privately owned, owner would prefer left path used
- Split Rail Fence
- Audubon; Way to south at bridge
- Terrapin Nests (39)
- Way 100 (Osprey Nest)
- Boathouse (38)
- Loagy Bay (Aquaculture Access)
- Lt. Island SW (Meadow Ave) (40)
- Lt. Island steps, Lt. Isl. NW
