2. Massachusetts Shellfish Initiative Task Force Meeting This Friday, Dec. 4 at 9 a.m.

The Massachusetts Shellfish Initiative (MSI) Task Force is holding a virtual public meeting on Friday, December 4, 2020 at 9 a.m. The meeting will be held via Zoom Webinar. The purpose of the meeting is to review recent work by the Steering, Scoping, and Assessment Committees and to begin process to develop a strategic plan.

Over the past two years, the MSI's Assessment Committee and Scoping Committee have produced extensive reports on the state's shellfish resources, shellfish fisheries, and other shellfish related activities in the Commonwealth. These reports were recently published and are available on the MSI's website. With the completion of these reports, the MSI is convening its Task Force to begin developing a strategic plan.

3. Coronavirus Food Assistance Program Update

Shellfish farmers, you still have a few days to apply. The deadline is next Friday, Dec. 11. We have been hearing that this is a great program, and there is no reason not to take advantage of it. If you had crop sales (seed or market size) in 2019, you are eligible to receive a check for about 10% of your 2019 sales. You need to go to your county Farm Service Agency office ASAP (see contact info below) and fill out the forms. Then, you should receive a check in 7-10 days. There is even a way for new growers with no 2019 sales to qualify.

After you submit your online application, the FSA office will generate and send you additional documents that need to be completed. Be sure you reach out to Francine Kealey ASAP if you have not heard from her office.

4. Commercial Shellfishing Permits on Sale

Due to the coronavirus, all shellfishing permits are being sold online this year. Click here to buy. PLEASE NOTE: There will be a two-business day turn-around time, so plan ahead. Permits will be on sale through January 31, 2021. Permits are valid January 1 — December 31, 2021. As always, you will need to renew your state commercial permit and obtain your seller's card before the end of January.

If you buy your permit in January, please remember that there will be a waiting period for us to turn it around for you, and you will not be able to shellfish during the waiting period. Once approved, permits will be put in the open slot in the back of the tax payment mailbox to the right of the back door to Town Hall. Please call the Shellfish Department with any questions or for assistance: 508-349-0325. For those who do not have a computer, Principal Clerk Jeanne MacLauchlan will be issuing permits at the Shellfish Dept. Office on the pier from 9 a.m. – noon on Wednesdays until the end of December. Permit applicants that did not hold a commercial shellfishing permit in 2020 or are not listed on the 2020 census will still have at least a two-day turn-around time even if they apply in person, so that we can make sure they meet the domicile requirement.
