Two agenda items generated good discussion: the addition of 7.6.1 Application Procedure to the Town of Wellfleet's Shellfishing Policy and Regulations was approved as was the addition of a Domicile Hardship Exception. In addition, it was agreed that a community-wide discussion on the expansion of aquaculture in Wellfleet should be had in the near future to balance all harbor users' interests in decision-making.

3. Wellfleet S.P.A.T. Still Has Funds Available to Help Wellfleet's Shellfishermen

Wellfleet S.P.A.T. has established the Wellfleet Shellfish Harvester Relief Fund to support Wellfleet's shellfishing families with essential household expenses (rent, mortgage, utilities, etc.) during times of crisis.
