We are looking for shellfishermen to go to the West Side and Jeremy's Point where we have reports of derelict racks. Thanks to all who can find time to lend a hand!

3. COVID-19 Vaccines Available to Shellfishing Industry as of March 22

On March 22, following the Governor's directive, certain workers, including restaurant and cafe workers; food, meatpacking, beverage, agriculture, consumer goods, retail, or food service workers; grocery and convenience store workers, and food pantry workers or volunteers, are eligible to sign up for a COVID-19 vaccine in Massachusetts. **This includes fishermen, seafood processers, and aquaculturists.**

The Cape Cod Regional Vaccine Consortium is working to identify eligible individuals who now qualify for the COVID-19 vaccine. Please fill out <u>this form</u> if you fall under one of the

eligible categories, need a first dose appointment for a COVID-19 vaccine, and either work or live on Cape Cod. All eligible individuals, including seasonal workers who have not started working yet, are encouraged to respond.

Eligible individuals who complete the form will be contacted by Cape Cod Healthcare by phone to schedule an appointment on Cape Cod for a COVID-19 vaccination in the next two weeks. By filling out the form, you are not scheduling an appointment, however, you will be contacted by Cape Cod Healthcare by phone shortly thereafter to schedule an appointment. 4. COVID Relief Funds Available

- a) The Fishing Partnership has received funds from the Cape Cod Foundation to help fishing families with direct financial assistance. These funds are available until June 30, 2021 or until they are exhausted. If any Barnstable County residents need help, Fishing Partnership Navigators are able to work with you to assist with paying household expenses including utilities, childcare, medical bills, food, transportation, rent and mortgage payments. Additionally, they have gas and grocery cards in varying denominations depending on the size of the family. - b) The Cape Cod Commercial Fishermen's Alliance has received funds from a philanthropic donor in response to the COVID-19 pandemic. As a commercial shellfisherman on Cape Cod, you may be eligible for a COVID-19 fuel reimbursement check.
 - a. What: a \$50 check to help subsidize fishing fuel costs no strings attached.
 - b. How: Fill out this <u>online form</u> to request your check. You must self-certify that your shellfish business suffered due to COVID-19 and that that you attempted to shellfish in 2020 (no proof or documentation needed, we'll take your word).
 - c. You must be at least 18 and rely on shellfish for at least half of your annual income (in a normal year).
 - d. If you have questions or would like to request a check over the phone instead of online, please call Steph at 508-737-1052.

Important: There is \$7,500 available for these reimbursement checks, which will be given out on a first come, first served basis until the funds run out. If you have more than one shellfisherman in your household, you may make a request for each shellfisherman, BUT the extra requests may not be honored unless there are funds still available after we process all requests.
