### 3. Shellfish Department Propagation Updates

We will be participating in the contaminated quahog relay again this year and planting clams in Chipman's Cove for the fall (and the Indian Neck Recreational Only Area) next week. We will begin cultching on June 1. We have ordered oyster and clam seed. We will deploy hats in the Cove and on our grant. Buoys for the spat collecting area in Chipman's will be placed by June 15, this year. We have six AmeriCorps project days booked between this Friday and June 25.

Deputy Constable Drew Ryan, who has been with us for three years, will be back mid-month until the end of June to fulfill his prior contract. He has decided to move on in search of full-time, year-round employment, which we were not able to offer him. We are sad to lose him as he has been a valuable asset to our department. We will be looking to hire someone to take his place starting July 1. If you see him, please thank him for his excellent service to the Town.
