

Town Recreational Shellfish Crier May 22, 2023

Dear recreational shellfish harvesters,

A very important decision is coming up about the future of Wellfleet Harbor. The Wellfleet Selectboard will be determining whether to continue to support the mitigation program to allow the dredging of Wellfleet Harbor and to keep the \$2.5M grant from the Commonwealth of Massachusetts to do the dredging of Area II (the Chipman's Cove Mooring Field).

As communicated by the Shellfish Department previously, this will mean that a 28-acre section of Blackfish Creek, from a little west of Drummer's Cove extending east toward the highway, will move into a specially managed status by the Shellfish Department. We will close it for three years and propagate it heavily with oyster seed and quahogs from the state-run contaminated relay, and eventually sea clam cultch. Our goal is to get to 25 oysters per square meter in the area as well as improve the water quality and richness in species biodiversity. After three years, we will evaluate these metrics and open it depending on what level of success we have achieved. We are very excited at the possibility of turning a mediocre resource area that is currently under-utilized into an area with increased shellfish populations with albeit limited in the beginning, but available harvest opportunities. And we hope that the benefits will also flow out towards Old Wharf Point, Field Point and Pleasant Point, improving shellfish populations in those open areas as well.
